

Description: High visibility warning waistcoat for non-professional use, manufactured from 100% Polyester, with reflective stripes.

Type: Waistcoat „TEDDY“, RSV-006. **Model:** 1114 002 150 XX.



This garment conforms to the basic hygiene and safety requirements stipulated by Regulation (EU) 2016/425 and the other quoted norms

Use: this waistcoat is designated for non-professional use, it is not meant to be used in working environments; waistcoats designed for such purposes conform to EN ISO 20471 - warning waistcoats for professional use.

The waistcoats provide high visibility and can be worn by both adults and young people. They are designed for visual indication of the user's presence under any lighting conditions both in daylight and when lighted by the headlights or spotlights of a vehicle in darkness or under street lighting.

These garments should be used by anyone exposed to such situations. In such situations this garment can significantly decrease the risk of an accident.

The waistcoat is worn as an outer garment. The garment must not come into contact with liquid chemicals, especially solvents, or with fire. It is also necessary to avoid excessive mechanical damage, especially to the retroreflective parts (tearing, disjunction etc.).

During shipping, the products are packaged in PE bags. The products must not be damaged or destroyed during shipping.

If used and stored correctly, **the durability** of the garments is determined by the maximum number of washing cycles and the specific maintenance symbols.

Laws, norms, regulations:

EN 1150:1999] High visibility warning garments for non-professional use - methods of testing and requirements.

Identification of the Notified Body that carried out the conformity assessment: Finnish Institute of Occupational Health, Topeliuksenkatu 41b, FI-00250 Helsinki, Finland. Notified Body č. 0403.

Use limitations: To provide the correct level of protection as described above, the garment must be worn closed at all times.

Storage: DO NOT STORE in places exposed to direct sunlight. Store in closed dry storage rooms, protect from radiant heat from heating units, store at least 1 m away from heating units. If the garment is wet, leave it to dry at room temperature before storing it away.

WARNING! The garment must be kept clean to maintain its function. If it is permanently soiled or faded, replace it immediately.

Please note: The garment will maintain its high-visibility characteristics for a maximum of 25 washing cycles. After 25 washing cycles, put the garment out of use.

Sizes: Marked by 2 reference measurements in conformity to EN ISO 13688.

Maintenance and cleaning: The user finds the product maintenance symbols on sewn-on label.

How to maintain at home: Not more than 25 washing cycles; washing as a synthetic material with max. temperature of 40 °C; do not use BIO laundry detergents and agents that contain optical highlighters; considerate handling; rinsing in cold water; short spinning; no bleaching; no tumble drying; no ironing; no chemical cleaning.

Manual cleaning of reflective strips:

1. Water 40 °C - soft cloth, sponge or soft brush.
2. Considerate laundry detergent or cleaning agent.
3. Rinse the clothes after cleaning and leave them to get dried.

The maximum number of washing cycles applies only for the properties related to high visibility.

Warning:

- Check the clothes' condition visually before every use. The clothes must be kept clean to remain functional. If they are dirty or pale, replace them immediately!!!
- If integrity of the clothing becomes disrupted (rupture, wearing out, material excessive thinning, unstitched seams etc.), the degree of protection is lower and the product becomes inconvenient in accordance with above specified legal and technical regulations.
- Repair them only using the materials and fabrics that meet the requirements of the respective standard.
- If the product is used, kept, or treated differently than as specified here in this document, it may be destroyed or its functions may be changed.
- The above-specified maximum number of washing cycles is not the only factor related to the life of the clothes. The clothes' life will depend on their using, storing etc.
- Wearing high visibility clothing does not provide a guarantee that the user will be visible in every situation.

If the clothing is used when strictly following the specified purpose, then there are no hazards that could endanger the user's health (the product must not be used in the circumstances that require other types of protective functions, e.g. protection against heat hazards, clothing caught by moving parts of a machine etc.).

Disposal: Disposal of clothes is regulated by legislation of individual countries or by local regulations. Disposal by burning.
